## **Argyll and Bute Beach Forum Education Events**



ABBF has recently held 2 education events in Tarbert on 18<sup>th</sup> September and in Dunoon on October 30<sup>th</sup>. A host of organisations worked in partnership to bring together an amazing 2 days of stimulating and thought provoking workshops to over 200 children & adults. The GRAB Trust's Beaches and Marine Litter project ran 3 different workshops covering the impacts of plastic & litter in the marine environment. Ecological & Biodiversity workshops were run by SNH, the HWDT, the Scottish Sea Angling Conservation Network & Argyll & Bute Council covering a wide range of species from sharks to machair bumble bees. Plenty of hands-on activities were also on offer, including a rocky

shore touch pool, creating bird artwork from waste kevlar rope & making squid wind socks from recycled materials. Feedback on the event from teachers & pupils alike was excellent, along with lots of requests to return again soon! ## MCS annual Beachwatch Weekend, 15<sup>th</sup> & 16<sup>th</sup> September

The marine litter surveys carried out this weekend help MCS to produce an annual summary report on the litter found on our beaches.



Park Primary School (on the left) cleans and surveys a stretch of Oban's Esplanade shoreline 4 times a year as part of their Eco-School's work under the Marine Conservation Society's Beachwatch programme. The latest clean-up resulted in 565 bits of litter being removed from the beach. The top 5 categories of litter were glass, plastic, polystyrene, paper and metal pieces. Two huge slabs of polystyrene were also uplifted.

## **Plastic shores movie**



# £6000 awarded to tackle flytipping in Clochkeil Dunes, Kintyre

The one-off agricultural waste includes asbestos corrugated roofing is located on Machrihanish SSSI dunes. The SSSI is the largest sand dune system in mainland Argyll and contains a diverse flora, including the only site in Kintyre for pyramidal orchid Anacamptis pyramidalis. The work to remove the waste will be carried out by the local contractor McFadyens in December.

The funding has been awarded from the £75,000 Flytipping Small Grants Scheme, which is administered by Keep Scotland Beautiful on behalf of Zero Waste Scotland, with support from the Scottish Flytipping Forum.

## One woman and her jar: Monitoring the water environment in Argyll

The wind sweeps across the beach. A seagull circles overhead. Just beyond the breaking waves, a woman stands alone, with a jar on the end of a long pole. A rather odd sight you may think but this is just an average day for Lynette MacDonald, Sampling Officer for SEPA. Lynette explains:

"As the principal environmental regulator for Scotland we carry out regular monitoring of freshwater sites such as rivers and lochs as well as marine and coastal waters sites all over the country. I work in the National Monitoring Team as a Sampling Officer and it is my responsibility to collect all the samples in the Argyll area."



During the bathing season (1 June to 15 September), SEPA officers take water samples at all designated bathing waters around Scotland. In Argyll, samples are taken at Machrihanish, Ganavan, Ettrick Bay on Bute and at Luss Bay and Millarochy Bay on Loch Lomond. The samples are checked for faecal indicators (bacteria). Water quality is then classified according to the levels of indicators that we find. The classifications are set by the Bathing Waters Directive. ## Clean up Scotland campaign

Keep Scotland Beautiful has announced that it will lead a nationwide massengagement campaign called Clean Up Scotland, which will get underway in 2013 and will run until the end of 2014. Clean Up Scotland aims to empower clean-ups to clear Scotland of litter and mess in time for hosting major events such as the Commonwealth Games and the Ryder Cup in 2014, and to gradually encourage zero

#### **Litter Grants**

The GRAB Trust has funding from EB Scotland to give small grants to groups and organisations that carry out a village or beach clean in the area of Argyll and Bute Local Authority. You need to inform one our key contacts previous to carrying out the clean up. You also have to fill in the application form "Application & Criteria for The GRAB Trust Litter Grants" in order for the money to be processed. The application form includes our criteria, key contact details and other useful information.

We can also lend you cleaning equipment (litter pickers, gloves and bags) and help you carrying out a risk assessment and organising the collection of the litter. Please get in touch with the project worker in your area for more information.
